### Develop an environmental policy



#### Overview

This standard describes the skill and knowledge requirements for those who are involved in developing an environmental policy. An environmental policy is a written statement summarising the organisation's intentions with regard to environmental performance.

This standard would be appropriate for:

A manager with responsibility for environmental management and/or sustainability An owner/manager of a business seeking to improve the environmental performance of the organisation

An individual with a specific brief to develop an environmental policy An environmental management systems co-ordinator or equivalent A consultant providing environmental advice.

This standard covers the review and evaluation of organisational commitments and the content of any existing environmental policies in relation to the organisation's environmental impacts with the intention of recommending improvements.

It also covers producing an environmental policy and communicating it to interested parties including top management.

- P4 Recognise relevant interested parties and seek their views on the content of an environmental policy
- P5 Identify improvements to organisational commitments and any existing environmental policies with respect to environmental performance
- P6 Ensure your findings are valid, recorded in a suitable format and based on recognised guidelines, applicable legislation and good practice.
- P7 Produce and communicate an environmental policy
- P8 Prepare a policy and ensure that it is based on the organisation's significant environmental aspects and impacts, applicable legislation, good practice and is consistent with other organisational commitments
- P9 Ensure that the policy includes a commitment to continual improvement in environmental performance
- P10 Ensure that the policy provides a framework for environmental objectives
- P11 Ensure the policy is clear and appropriate to the nature and scale of the organisation and is in a suitable format for interested parties including top management
- P12 Communicate the policy to interested parties including top management
- P13 Encourage feedback from interested parties on the content of the policy.
