Maintain fishing operations



Overview

This standard is about monitoring and maintaining fishing operations so that the objectives of the fishing activity are safely met. It includes being able to observe all aspects of the fishing activity and provide advice and guidance to help those involved with implementation, to overcome difficulties and variations from planned outcomes.

This standard requires the ability to respond to variations in expected numbers of fish, changes in water conditions and effectiveness of equipment. It also requires the ability to maintain the condition of fish during capture, storage, data collection and release.

This standard requires the ability to maintain the following fishing operations:

- 1. netting
- 2. hook and line
- 3. trapping
- 4. draining down

This standard requires that you ensure work is completed safely in line with legal health and safety requirements and that you ensure work maintains biosecurity and minimises environmental disturbance at all times.

The legislation controlling the application of this standard will vary depending on the location of the fishery within England, Wales, Northern Ireland or Scotland.
