Assist the establishment of reared gamebirds in the wild



Overview

This standard describes your role in establishing gamebirds in the wild. It relates to the work activities that you undertake to support the release of gamebirds and establish them at specified locations on the sporting estate. This standard is aimed at those who work in game conservation on either a full-or part-time basis, and can be applied to any sporting estate involved in the release of game.

To meet this standard you will be able to:

- 1. establish gamebirds in release areas
- 2. maintain the welfare of gamebirds during release
- 3. support the release process to establish gamebirds in the wild
- 4. maintain gamebirds in specified locations on sporting estate.

This standard relates to the following applications or context:

Prepare release areas in respect of: shelter protection

Observe behaviour in terms of: feeding movement

Achieving release specifications in terms of: location of gamebirds distribution of gamebirds

Taking action in respect to the following disturbances: human pest and predator

You must be able to:

Assist with the care of gamebirds during release

- P1 carry out work safely in line with health and safety requirements
- P2 **prepare release** areas to optimise the survival of juvenile gamebirds during release
- P3 prepare poults for release
- P4 transfer juvenile gamebirds safely to release areas in a way which minimises stress
- P5 establish juvenile gamebirds in release areas at required density
- P6 handle juvenile gamebirds in a manner which maintains their welfare and minimises stress
- P7 provide feed and water to suit the development needs of juvenile gamebirds
- P8 observe **behaviour** and condition of gamebirds and report any signs of stress or disorder
- P9 maintain accurate records

You must be able to:

Assist with the release and establishment of gamebirds into the wild

- P10 carry out work safely in line with health and safety requirements
- P11 establish the process of gamebird release so that the release specification can be achieved
- P12 provide feed and water to control the location and distribution of released birds to meet release specification
- P13 maintain pest and predator controls to limit their impact on the released gamebirds
- P14 observe released birds and report any behaviour which varies from that expected
- P15 take action to minimise the impact of disturbances likely to disrupt planned release
- P16 maintain accurate records of release
