Carry out comprehensive assessment for alcohol and other substances



Overview

This standard is about assessing the needs of individuals who use alcohol and other substances who have complex requirements and/or those people who require more intensive and/or structured care programmes. It covers assessment that is on-going throughout the contact with the substance use service and the wider support system. It includes:

- 1. preparing for a comprehensive assessment for alcohol and other substances
- 2. assessing the individual's substance use, support network and related problems
- 3. assessing possible risks to the individual
- 4. assessing the individual's understanding of services available

This standard relates to substances which may include alcohol, prescription and over-the-counter medicines, controlled or currently legal drugs, and new psychoactive substances. Users of this standard will need to ensure that practice reflects up to date information and policies.

- P17 encourage the individual to ask questions, seek advice and express any concerns
- P18 assess the nature of the individual's substance use problems and any other problems they may have
- P19 use the results of the assessment to inform the collaborative care plan
- P20 ensure your assessment takes account of the individual's needs, strengths, views inherent risks, safeguarding, and the legal duty of care to the individual and others
- P21 keep accurate, legible and complete records of the assessment to inform the development of a care plan and for evaluation purposes
- P22 assess and review at appropriate intervals once the individual has commenced a care plan
- P23 provide individuals with accurate and clear information on systems for making complaints about the assessment system and appealing on the decisions
- P24 seek support from the appropriate person as soon as possible when there are any problems with the assessment
- P25 discuss assessments with other members of the substance use service team in order to ensure consistency of approach
- P26 ensure your assessment records are in a format and level of detail which can be audited against locally agreed standards
- P27 record and report changes made and any effect this might have on the individual within confidentiality agreements and according to legal and organisational requirements

Knowledge and understanding

You need to know and understand:

- K1 legal, organisational and policy requirements relevant to your role and the activities being carried out
- K2 local systems, procedures and protocols for safeguarding children and young people
- K3 how to obtain information from individuals and other agencies in line with protocols
- K4 how to pass information obtained during an assessment to another agency in line with local protocols
- K5 how to evaluate requests for assessment according to their priority in line with your organisation's criteria
- K6 how to adapt communication styles in ways which meet the individual's needs, strengths and capabilities
- K7 how to involve an individual in the assessment of their needs and options
- K8 how to assess and manage complex needs and co-morbidities
- K9 how to assess the individual's strengths and coping strategies
- K10 how to assess an individual's understanding of services available and readiness to engage in a treatment programme
- K11 how to use motivational interviewing techniques to assess the individual's motivation
- K12 how to assess individuals who are under the influence of alcohol or other substances and the action to take if the assessment cannot be undertaken
- K13 who can provide support when there are any problems with the assessment
- K14 the importance of adhering to locally agreed criteria and documentation when carrying out assessments
- K15 how to record the outcomes of assessments and use the assessment to inform the development of a comprehensive care plan
- K16 how to review assessments at appropriate intervals once an individual has commenced a programme of care
- K17 your responsibility and accountability for the wellbeing of individuals
- K18 how to recognise the signs of injury, abuse or neglect in the individual and how to raise concerns with the appropriate person or agency

- K19 how to support the choice and wellbeing of the individual which is appropriate to their needs and preferences
- K20 how substance use of others can impact on the emotional, social, physical and psychological development of children, young people and significant others and how to respond appropriately
- K21 how to take account of a child or young person's age and maturity when considering the impact of others' substance use on them
- K22 the principle of confidentiality and the implications for your practice
- K23 how to support individuals to complete documentation
- K24 the importance of monitoring the situation regarding an individual's use of substances, and how to do so
- K25 how to assess the risk to individuals, children, families and to others from their substance use and/or co-existent problems and the appropriate action to take
- K26 the importance of regularly reviewing risk assessments
- K27 the signs and implications of a range of substance use related problems
- K28 the principles of equality, diversity and anti-discriminatory practice and how they are applied
- K29 how age, gender, cultural and social background, including the choice of substance being used can affect the working relationship
- K30 ways of keeping your knowledge about substances and indications of substance use up to date
- K31 how to understand the language used by substance users in your locality
- K32 sources of information on health and wellbeing services providing treatment intervention service for substance users
- K33 the range of treatment interventions and assessment services available in your locality and the process for referring individuals to these services
- K34 the eligibility criteria and protocols for accessing services in your locality
- K35 national, local and organisational treatment priorities and resource constraints
- K36 how to respond to individuals who do not want to be referred to other services
- K37 the importance of keeping full and accurate records, and how to do so in line with organisational requirements
