- P3 select and prepare equipment and consumables in accordance with manufacturer's instructions and the requirements of the procedure
- P4 accurately identify and rectify the cause of any difficulties in obtaining an accurate recording
- P5 obtain clear, accurate and complete data of the individual's cardiovascular status
- P6 alert appropriate medical personnel where accurate data is unobtainable

- K5 operating principles and specifications of the equipment
