Performance criteria

- You must be able to:*
- P1 research the advice and information needs of different recipients in ways appropriate to need and which take account of organisational constraints
 - P2 provide advice and information at an appropriate time and place and in an appropriate form and manner
 - P3 provide advice which is accurate, current, relevant, and sufficient for need
 - P4 remain consistent with organisational policy, procedures and constraints
 - P5 support advice given with reasoned argument and appropriate evidence
 - P6 verify recipients' understanding of the information and advice given
 - P7 maintain confidentiality consistent with organisational and legal requirements
 - P8 obtain and use feedback from recipients to improve the way advice and information is provided where appropriate

Knowledge and understanding

You need to know and understand:

- K1 how to communicate advice and information effectively both through speaking and in writing
- K2 how to develop and present a reasoned case when providing advice to others
- K3 the importance of confirming the recipients understanding of information and advice provided and how to do this
- K4 the importance of providing advice and information and your role and responsibilities in relation to this
- K5 the types of advice and information which people may require
- K6 how to identify information needs
- K7 situations in which it is appropriate to act on one's own initiative in giving information and advice
- K8 the importance of seeking feedback on the quality and relevance of the advice and information provided and how to encourage such feedback
- K9 the importance of checking the validity of advice and information provided to others
- K10 how to ensure accuracy, currency sufficiency and relevance of advice and information
- K11 the principles of confidentiality when handling information and advice – what types of information and advice may be provided to what people
- K12 organisational policies, procedures and resource constraints which may affect advice given
