Support individuals with long term conditions to manage their respiratory function



Overview

This standard covers the way practitioners can support individuals with long term conditions to manage their respiratory function. The practitioner will need to review all relevant information about the individual's condition and symptoms, and confirm with them the actions being taken to manage their respiratory function. The practitioner can monitor the use of interventions, and identify how effective they have been and whether any problems have emerged. They will also be in a position to assist the individual to monitor their own respiratory function.

Users of this standard will need to ensure that practice reflects up to date information and policies.

Performance criteria

- You must be able to:*
- P1 respect the individual's rights and wishes relating to their privacy, beliefs, and dignity, and obtain informed consent whenever appropriate
 - P2 provide support and information to enable the individual, and the carers they specify, to enable them to make informed choices throughout the management of their respiratory function
 - P3 review all relevant information about the individual's condition and symptoms
 - P4 confirm with the individual that they are able to manage their respiratory function, and where this is not possible, ensure that the relevant practitioners provide them with appropriate respiratory care
 - P5 identify the most appropriate interventions to use with the individual to manage their respiratory function
 - P6 enable the individual to monitor their responses to the use of interventions, and to report any concerns or problems with them
 - P7 establish whether the interventions are being suitably provided and utilised
 - P8 monitor the condition of the individual, and take appropriate action to respond to any respiratory difficulties or adverse effects
 - P9 keep accurate, legible, and complete records, and comply with all the relevant legal, professional, and organisational requirements and guidelines

Knowledge and understanding

You need to know and understand:

- K1 the relationships between individuals and their carers, and how much they might want their involvement
- K2 the difficulties with communication that can arise as a result of specific long term conditions, and how this changes according to fluctuations of symptoms
- K3 the role of carers and others in facilitating communication
- K4 relevant legislation and the parts relating to the care of individuals, including the role of practitioners and clinical practice, human rights, data protection, and health and safety
- K5 the principles of informed consent, including implied consent and expressed consent, and how these are applied in practice to protect individuals
- K6 the symptoms of specific long term conditions and how they can be recognised
- K7 how symptoms interact with each other
- K8 how symptoms can mask or be indications of other non-long term conditions and co-morbidities
- K9 the impact of symptoms on behaviour and lifestyle, and how it can be minimised
- K10 the requirements and needs of individuals, and the resources and services that are available to help them
- K11 the current issues and research debates on long term conditions
- K12 authoritative information and available resources including national, local and voluntary agencies for practitioners, individuals, and carers
- K13 the changes that occur during the course and different stages of specific long term conditions
- K14 the practitioners that are available to individuals, and how to obtain help from them
- K15 the roles and responsibilities of individuals for managing their own long term conditions
- K16 the services, equipment, and other resources and benefits available to help manage long term conditions
- K17 when to review the management of long term conditions
- K18 the aetiology, course, and progression of specific long term conditions
- K19 the possible causes of specific neurological conditions, including genetic or environmental factors
- K20 the anatomy and physiology relevant to specific long term conditions
- K21 the symptoms, complications, and outcomes of specific long term conditions
- K22 the short, medium, and long term effects of specific long term conditions

- K24 baseline levels of respiratory function for individuals

- K27 the methods and equipment that can be used to assess and monitor respiratory functions
- K28 the interventions available for assisting the management of respiratory functions
- K29 the services and resources available for dealing with difficulties with respiratory functions
