Manage major emergency situations



Overview

This standard covers the management of major emergency situations or incidents, including Major Incidents, through interacting with other services and co-ordinating the emergency health care provided.

Users of this standard will need to ensure that practice reflects up to date information and policies.

Manage major emergency situations

Performance criteria

You must be able to:

- P1 undertake a thorough survey of the situation to determine existing or potential threats to the safety of yourself, any injured parties and others
- P2 activate warning devices to protect the vicinity of the incident
- P3 take steps to minimise the risks to bystanders
- P4 identify potentially hazardous items, individuals or environments and minimise the hazard where possible
- P5 continually monitor the situation, reporting and actioning changes as required to minimise risks
- P6 remove or protect the individual(s) from hazards or further injuries where possible
- P7 ensure that practitioners and others in the area wear appropriate personal protective equipment and adhere to agreed procedures for their protection
- P8 ensure your safety and that of individuals, practitioners and others such as family members or carers as appropriate to the situation.
- P9 establish priorities for action that are:
 - P9.1 clear
 - P9.2 justifiable on the basis of the information available to you at the time
 - P9.3 appropriate given the nature and scale of the situation/incident
- P10 determine accurately the existing care expertise within the immediate emergency team and its suitability to the needs of the situation
- P11 make an accurate and prompt assessment of the need for:
 - P11.1 specialised personnel
 - P11.2 specialised equipment
 - P11.3 additional personnel/equipment
- P12 request any specialised and/or additional personnel/equipment promptly and in line with relevant procedures
- P13 comply fully with Major Incident Plans when dealing with large scale incidents
- P14 report the circumstances of the situation/incident to the control/operation room in a clear, logical and concise manner
- P15 use agreed procedures for the exchange of information with others
- P16 correctly interpret safety/hazard signs and symbols when present, and report them to the appropriate authority
- P17 inform and advise others and specialised personnel fully of:
 - P17.1 any actions they may need to take to ensure the safety of yourself, the individual(s) involved in the situation/incident and others
 - P17.2 any actions you intend to take which may influence the way they carry out their role

- P17.3 any actions you need to take for which their support is needed
- P18 provide instructions and directions in a clear and calm manner
- P19 make requests for assistance in accordance with Major Incident Plans
- P20 report changes to the situation or circumstances of the emergency immediately to those whom they may affect
- P21 establish and sustain effective liaison with the senior personnel of other organisations in attendance at the incident and agree lines of command with them
- P22 clear all unnecessary personnel and bystanders from the area
- P23 ensure your safety as appropriate to the situation

Manage major emergency situations

Knowledge and understanding

You need to know and understand:

- K1 why it is important to explain your role, responsibilities and accountability to individuals, and obtain informed consent to the assessment process
- K2 why it is important to continually monitor a situation, reporting and acting on any changes appropriately
- K3 the meaning of standard safety/hazard signs and symbols
- K4 the processes you would go through in establishing priorities for action
- K5 the ABC principle when prioritising individuals
- K6 why it is important to make effective and systematic use of all the information available to you
- K7 the importance of making a thorough survey of a situation/incident
- K8 the types of hazards likely to be found at different sorts of situation/incident and how they can be minimised
- K9 the kinds of medical conditions with which individuals who have been involved in Major or complex incidents are likely to present and the priorities associated with these
- K10 the types of personal protective equipment available and their use
- K11 what factors should be taken into account in assessing the need for specialist or additional personnel/equipment
- K12 the scope of practice of specialised personnel
- K13 the operating features of specialised equipment
- K14 the warning devices that are available and how they should be operated
- K15 the importance of clear and appropriate communication at the scene of a situation/incident
- K16 the sort of circumstances in which you would need to inform and advise specialised personnel of actions you are to take and that they may need to take
- K17 the steps you can take to minimise hazards to bystanders
- K18 situations in which it would be important to remove or protect the individual(s)requiring treatment and how this should be undertaken
- K19 procedures to be followed in requesting specialised/additional resources
- K20 the processes followed to arrive at a justifiable conclusion as to the assignment of priorities to individuals, as a result of the symptoms they present with
- K21 the steps to take when the assessment of individual priority is beyond your experience and scope of responsibilities
- K22 how to ensure effective liaison between yourself and the senior personnel of other organisations
- K23 local Major Incident Plans and the roles and responsibilities of your organisation and others
- K24 the prioritisation protocols to be applied within Major Incident Plans and in relation to complex situations

K25 how to interpret and apply legislation to the work being undertaken
