Initiate, and participate in, networks and discussion groups



Overview

This standard covers work that is carried out in relation to networks and discussion groups. The purpose of these networks and discussion groups is to improve the flow of information and knowledge for the delivery of care. Networks and discussion groups may be virtual, face to face, or mixed. You will need to be able to set up networks and discussion groups. This will involve anticipating the need for networks and discussion groups, checking whether existing networks and discussion groups are in place, and working with others to set up networks and discussion groups. You will also need to be able to take part in networks and groups. This will involve establishing the best ways to participate and keeping accurate records of outcomes.

Users of this standard will need to ensure that practice reflects up to date information and policies.

- P1 identify the need for, and purpose of, networks and discussion groups to improve care delivery
- P2 check whether there are existing networks and discussion groups that already meet the identified need and purpose
- P3 establish suitable terms of reference for the networks and discussion groups for them to be effective
- P4 liaise with relevant others to set up the networks and discussion groups
- P5 communicate and promote the use of the networks and discussion groups to encourage participation
- P6 identify networks and discussion groups relevant to your area of responsibility
- P7 identify the purpose of networks and discussion groups relevant to your area of responsibility
- P8 establish the best way to access and participate in networks and discussion groups
- P9 participate in networks and discussion groups to identify relevant information and knowledge
- P10 keep accurate records of the useful outcomes of your participation in networks and discussion groups
- P11 pro-actively communicate the actions and outcomes of networks and discussion groups to relevant others

- K13 the importance of keeping up to date with developments relevant to your area of responsibility
- K14 the trends and developments in the sector which impact on the need for information and knowledge
- K15 the ways in which ICT can be used to help capture knowledge
- K16 the security issues attached to the use of information and knowledge
