Assist in the support and monitoring of patients within the perioperative care environment



Overview

This standard covers carrying out delegated care activities that are within your own sphere of competence to assist the registered practitioner in the support, care and monitoring of patients before, during and after clinical procedures within the perioperative care environment. You will be working under the direction of a registered practitioner. This standard does not include you taking measurements of physiological parameters. Users of this standard will need to ensure that practice reflects up to date information and policies.

Assist in the support and monitoring of patients within the perioperative care environment

Performance criteria

You must be able to:

- P1 apply standard precautions for infection prevention and control and take other appropriate health and safety measures as appropriate
- P2 clarify and confirm your role in providing support to and monitoring the patient with the appropriate member of the care team
- P3 provide support, care to the patient, within the constraints of the setting and the procedure, that takes due account of their:
 - P3.1 individual needs, expressed personal beliefs, preferences and views
 - P3.2 plan of care
- P4 effectively monitor the patient's wellbeing and individual needs at all times, paying close attention to any areas of particular concern, as highlighted in the plan of care
- P5 maximise the patient's comfort and dignity at all times, within the constraints of the setting and the procedure
- P6 encourage the patient to express feelings of discomfort, pain or distress
- P7 answer questions and concerns from the patient clearly, accurately and concisely within own sphere of competence and responsibility
- P8 refer any questions and concerns from or about the patient relating to issues outside your responsibility to the appropriate member of the care team
- P9 minimise factors which may cause undue stress or distress to the patient within the constraints of the setting and the procedure
- P10 promptly identify any unexpected change in the patient's condition, or other cause for concern, and report this immediately to the appropriate person
- P11 promptly seek advice from the appropriate member of the care team where you are unsure of how best to support the patient
- P12 pass relevant information on the patient's care and individual needs to other members of the care team who will be involved with them, and clearly and accurately enter this information into the necessary records as directed

Assist in the support and monitoring of patients within the perioperative care environment

Knowledge and understanding

You need to know and understand:

- K1 the current European and National legislation, national guidelines, organisational policies and protocols in accordance with Clinical/Corporate Governance which affect your work practice in relation to assisting in the support and monitoring of patients within the perioperative care environment
- K2 your responsibilities and accountability in relation to the current European and National legislation, national guidelines and local policies and protocols and Clinical/Corporate Governance
- K3 the duty to report any acts or omissions in care that could be detrimental to yourself, other individuals or your employer
- K4 the importance of working within your own sphere of competence and seeking advice when faced with situations outside your sphere of competence
- K5 the importance of applying standard precautions and the potential consequences of poor practice
- K6 the importance of checking patient perioperative care plans prior to commencing support and monitoring activities
- K7 the importance of both verbal and non-verbal support to patients undergoing clinical procedures in the perioperative environment
- K8 the ways in which patient rights and choice may have to be restricted because of the nature of the perioperative environment and procedures
- K9 the effect which patients' personal beliefs and preferences may have on their behaviour and attitude in relation to the perioperative environment settings
- K10 the effects of pre-medication and sedation on patients, and the difference re-medication makes to the support, care and monitoring activities required
- K11 your role in supporting, caring, and monitoring patients, and how this relates to other members of the care team
- K12 how perioperative settings and procedures may cause stress and distress to patients and how environmental factors which cause stress and distress can be reduced
- K13 the signs of patient distress and how to support patients who are, or who may become, distressed
- K14 the importance of close observation of patients, and of reporting any concerns without delay
- K15 the aspects of patients' wellbeing and needs which should be monitored
- K16 the importance of accurately reporting and recording required information related to supporting and monitoring patients within the perioperative environment
- K17 the information, including types of change in patients' conditions, which

- should be recorded in relation to patient monitoring, and related systems and procedures
- K18 the importance of immediately reporting any issues which are outside your own sphere of competence without delay to the relevant member of staff
