Overview

This will include use of a range of techniques for researching and gathering information.

Users of this standard will need to ensure that practice reflects up to date information and policies.

- P2 arrange time and location to discuss and explore individual's needs which is suitable for their personal context and the topic to be discussed
- P3 introduce yourself to individuals and explain your role in their health care
- P4 use appropriate tools and techniques to identify the specific needs of individuals
- P5 communicate with individuals with sensitivity and respect for their level of knowledge, experience and understanding
- P6 identify the concerns and priorities of individuals and discuss options with a realistic view of associated opportunities and constraints
- P7 protect the confidentiality and dignity of individuals at all times
- P8 work within ethical, legislative and regulatory guidelines and codes of practice
- P9 agree specific learning, development and support needs of individuals, balancing needs of patients with those of their carers and families
- P10 agree next action and confirm individual's understanding of next steps and expectations of their participation
- P11 record agreements and actions accurately, in agreed format and ensure that information is passed to correct people for next steps to be taken

 - K5 how to identify, use and evaluate criteria for success

 - K9 requirements for medication, aids, support or other facilities related to the individual's condition
 - K10 the range, type and likely effectiveness of aids, support groups and interventions to assist the individual in managing their condition
 - K11 the knowledge and skills required by individuals to ensure their effective self-management of their condition
 - K12 the difference between misinformation and alternative views of practice
 - K13 holistic concepts and approaches to health and social well-being
 - K14 the ethical, legislative and regulatory guidelines and codes of practice applicable to the clinical area or defined condition
 - K15 the key theories of learning and development and their application in a healthcare context
 - K16 individual learning styles and the factors influencing effective learning
 - K17 methods of evaluating learning and development against a range of criteria
