### Overview

This standard covers the assessment of the health and wellbeing needs of the population and the outcomes of services etc over time. This includes evaluating, monitoring and communicating information, knowledge and statistics about health and wellbeing needs and outcomes.

Users of this standard will need to ensure that practice reflects up to date information and policies.

  - P6 collect accurate quantitative and qualitative field data when secondary data is unavailable
  - P7 manage, analyse and interpret data, information and knowledge using methods appropriate to:
    - P7.1 the initial questions
    - P7.2 the nature of the data, information and knowledge
  - P8 appraise and synthesise data, information and knowledge appropriately and create new information that identifies:
    - P8.1 consistency and inconsistency in outcomes
    - P8.2 any limitations in data, information or knowledge and the analyses used
  - P9 continually hold issues raised about data, information and knowledge open to question so that those sections of the population who are at risk can be identified
  - P10 describe problems accurately, communicate them to relevant others and make appropriate recommendations on the actions they should take
  - P11 monitor data, information and knowledge at appropriate intervals and take the necessary actions as a result of this surveillance

### Knowledge and understanding

- K1 accessing, interpreting, applying and synthesising the following types of data and information:
  - K1.1 community and population views of health and wellbeing
  - K1.2 data on the relationship between the physical environment and health and wellbeing
  - K1.3 data on the relationship between the social environment and health and wellbeing
  - K1.4 routinely available data on reproduction, disability, illness, disease and death
  - K1.5 census data - key indicators and projections
- K2 how the social construction of illness (and other related concepts) may affect the analysis and make cross-comparisons between different societies
- K3 how to describe the health and wellbeing of local populations using secondary data and make comparisons with other populations to identify localities or groups with poor health and wellbeing
- K4 the need for and how to undertake direct or indirect standardisation
- K5 how to apply quantitative and qualitative methodologies to the assessment and surveillance of the health and wellbeing of a population including recognition of the validity, reliability and cost-effectiveness of the different methods
- K6 how to apply a range of different information management methodologies and statistical packages to the analysis and interpretation of health data
- K7 how to assess the importance of different risk factors in a given population, including socio-economic, lifestyle, ethnic and genetic factors
- K8 how to analyse data on time trend and geographical bases to address local issues using spreadsheet and database skills
- K9 the limitations of small area analysis, and how to combine small area measures with routine data
- K10 how to frame research questions for the collection and analysis of data and information about health and wellbeing and related needs
