## Interpret results of research and development activities



---

### Overview

This standard is about interpreting results of research and development activities. It may involve the researcher interpreting results from a single hypothesis, single researcher activity, on own research project or as a member of a research team. Interpretation methods may be qualitative or quantitative and may range in scale from simple to complex analyses.

Users of this standard will need to ensure that practice reflects up to date information and policies.

- P1 base your interpretation on results which are confirmed to be as reliable as possible
  - P2 use and apply consistently valid interpretative methods
  - P3 ensure interpretation of results is valid

  - P5 assess the results of research against the original objectives
  - P6 investigate reasons where the research has failed to achieve its objectives and provide clear explanation
  - P7 make a clear distinction between the results and the interpretation placed upon them
  - P8 make recommendations based on the interpretation of results

- K10 sources of support and advice and how to access them
