Develop inferences from intelligence analysis

You must be able to:

- P1 apply appropriate methods to identify key findings from the information
- P2 identify significant relationships, gaps, anomalies and patterns that occur within the information
- P3 identify further information collection and analysis tasks that should be undertaken by self and others
- P4 explain key findings clearly and accurately to others
- P5 develop and test hypotheses
- P6 identify inferences that need to be tested
- P7 provide evidence for the structure and logic for your inferences

Make judgements based on the intelligence analysis methodology

You must be able to:

- P8 identify any significant features of the activities
- P9 identify changes or developments in the activities
- P10 provide clear forecasts of developments, the likely consequences and potential impact of the activities
- P11 draw conclusions that are reasonable and supported by the results of the analysis methodology
- P12 provide a clear and well-structured rationale for the conclusions
- P13 differentiate clearly between fact and opinion when presenting your conclusions
- P14 comply with all relevant legislation, codes of practice, standards, protocols, procedures and guidelines

Knowledge and understanding

You need to know and understand:

- K1 the types of inferences that can be made
- K2 how to develop and test hypotheses
- K3 how to test different types of inferences
- K4 the types of interpretation methods that can be used
- K5 the types of relationships, gaps, anomalies and patterns that could occur
- K6 the circumstances that could lead to the need for further information or analysis
- K7 how to provide a rationale for any key features that are identified
- K8 when forecasts can be made
- K9 the types of features in the current activities that could be significant
- K10 the types of predictions that can be made with any certainty
- K11 the likely consequences of different activities
- K12 how to draw findings from the results of the analysis methodology
- K13 how to present findings, including those that indicate the need for urgent action
- K14 the relevant national, local, professional, and organisational requirements relating to information usage, its handling and analysis
- K15 the reasons why it is important to comply, and the potential consequences of non-compliance, with relevant legislation, codes of practice, standards, protocols, procedures and guidelines
