Review the type of information used in intelligence analysis processes



Overview

This standard is about reviewing the type of information used in intelligence analysis processes. You will need to agree terms of reference with the client. Clients are defined as the person responsible for the setting of the task or requesting the review, not necessarily the sole recipient or customer. You will need to look at the sources of information, assess the reliability and validity of information and identify any features of the information that have a significant impact on intelligence analysis processes. You will also need to develop a business process map to show the flow of information and make recommendations on any potential changes in the process.

You must be able to:

- P1 establish and agree with the client a terms of reference for conducting a review
- P2 identify the type and amount of information available in the organisation for use in an intelligence analysis process
- P3 identify the different sources of information used for intelligence analysis processes
- P4 assess the reliability and validity of the information used for an intelligence analysis process
- P5 identify any features of the information that have a significant impact on the effectiveness of intelligence analysis processes
- P6 develop a clear business process map to show the flow of information
- P7 consider the impact of any potential changes on originators and other users of the information
- P8 provide a clear rationale for recommendations on potential changes in the intelligence analysis process
- P9 record the recommendations in an agreed format according to organisational requirements
- P10 comply with all relevant legislation, codes of practice, standards, protocols, procedures and guidelines
