Review and evaluate current service provision



Overview

This standard is about reviewing and evaluating current service provision using agreed approaches. You will need to review and analyse existing service provision and then evaluate whether it is meeting the required objectives. You will also need to report your findings in accordance with organisational requirements.

Review and evaluate current service provision

Knowledge and understanding

You need to know and understand:

- K1 the relevant legislation in relation to the service provision with which you are concerned
- K2 the legislation and guidelines relevant to commissioning in your occupational area and where to obtain information and guidance about this
- K3 the relevant organisational requirements and expected outcomes in relation to service provision
- K4 the ethics and requirements of sustainability as applied to the service provision with which you are concerned
- K5 the political landscape with regard to commissioning in your area
- K6 relevant research findings in relation to the service provision with which you are concerned
- K7 how to ensure that relevant data is used in accordance with current guidelines and legislation
- K8 the use of resource mapping to inform decision making
- K9 the ways in which the policy landscape is currently changing and how this may affect service provision
- K10 the wider views of the public and service users in relation to service provision
- K11 the approaches available for reviewing and evaluating current service provision (e.g. service user surveys, contract reviews, benchmarking)
- K12 the range of providers in relation to the service provision with which you are concerned, and the potential of related providers
- K13 how to report the results of your review and evaluation
