Plan, supervise, enforce and review sentences in the community



Overview

This standard is about planning, supervising, enforcing and reviewing sentences served in the community, and includes addressing any difficulties with individuals in ensuring effective participation.

Sentences served in the community includes those arising from, for example, community orders, suspended sentence orders and parts of sentences served in the community under licence following release from custody.

In working with offenders you are expected to consistently display the skills of pro-social modelling, offender engagement and professional judgment to encourage offenders to desist from their offending behaviour and to reduce the risk of re-offending.

There are four elements

- 1. Plan the supervision of individuals serving sentences in the community
- 2. Supervise individuals serving sentences in the community
- 3. Enforce court orders and statutory licences

4. Monitor and review the progress of individuals serving sentences in the community

Target group

This standard is aimed at workers who contribute to the supervision, review and enforcement of offenders serving sentences in the community.

	7. identify the information that may be made available to others as a result of the interventions, and inform individuals accordingly
	8. seek advice and support, where appropriate
	9. maintain records in line with your organisation's requirements
	Supervise individuals serving sentences in the community
	10. prioritise cases where individuals are at greatest risk of serious harm and/or re-offending when supervising the whole case load
	11. agree the respective roles and responsibilities with others who are working with individuals, in relation to maintaining regular contact and supervision
	12. clarify with individuals how supervision will take place, the requirements of
	their sentence, and what will happen if they fail to comply
	13. supervise individuals using methods which are consistent with statutory requirements and their sentences, deal with issues of control, and maintain appropriate role boundaries
	14. communicate using techniques appropriate to the individual and their needs15. encourage an open exchange of views and information, minimising any
	constraint to communication

16. offer individuals constructive feedback on progress, encouraging them to explore and review their perception of their offending behaviour

17. issue warnings to individuals when there is a risk of non-compliance

review the level of intervention to ensure that levels of risk are managed
 encourage individuals to discuss their previous successes in overcoming obstacles to change, including the known triggers to their offending behaviour and how these can be avoided

20. feedback to individuals on positive changes in their attitudes and behaviour 21. communicate information to the relevant person(s) who require and are entitled to it

Enforce court orders and statutory licences

22. obtain sufficient information from relevant others in cases of apparent noncompliance, verifying the information obtained and establishing its level of seriousness

23. establish reasons for apparent non-compliance with individuals and those working with individuals

24. warn individuals of the potential consequences of non-compliance using methods which are likely to secure compliance with the order or licence25. seek advice and support when team discussion and supervision are appropriate, and record any decisions reached

26. take appropriate breach actions, consistent with agency policy and statutory requirements

27. prepare an accurate report in cases where there is a breach of licences or orders, containing sufficient information for prosecution

28. forward breach reports to the breach prosecutor within the necessary timescales

Monitor and review the progress of individuals serving sentences in the community

29. conduct reviews using the relevant assessment tools
30. hold regular review sessions with individuals using techniques which encourage them to express their views, reflect on progress, and evaluate the effectiveness of their chosen strategies and the support provided
31. offer individuals constructive feedback on their progress
32. identify any changes in the individuals' personal circumstances or context which may have influenced their behaviour or motivation to change
33. establish new goals and objectives with individuals where required, and make any necessary changes to the plans to enable successful completion, including the consideration of early revocation

34. discuss possible changes with relevant others on the implementation of the sentence, including multi-agency public protection panels and partner agencies

Legislative, regulatory and organisational requirements

 legal and organisational requirements which relate to the enforcement of sentences in the community, and their impact for your area of operations
 legislation, policies and procedures relating to data protection, health and safety, diversity and their impact for your area of operations

3. the role of your organisation and the services which it provides in relation to planning, supervising, enforcing and reviewing individuals serving sentences in the community

4. organisational policy and procedures regarding confidentiality of information and the disclosure of information to third parties, and the specific circumstances under which disclosure may be made

5. the limits of your authority and responsibility, and the actions to take if these are exceeded

6. good practice communication techniques relevant to the situation and how to apply them

7. the importance of applying statutory powers, and the associated responsibility to local communities, victims and individuals of using such powers8. the types of statutory powers available for the enforcement of community sentences, including the different methods and approaches which may be used9. the procedures for managing offenders assessed as posing a risk of serious harm

10. the impact of crime on victims and their need for protection, respect, recognition and information

11. the ways in which the physical, social, psychological and emotional development of individuals affects their behaviour and its associated patterns12. relevant research into effective practice in relation to the factors which may be relevant to individuals' difficulties, including triggers and patterns of offending behaviour

13. the ways in which stereotyping and discrimination might affect risk assessment and how to guard against this

14. the issues involved in risk identification and prediction, and methods for doing this

15. why it is important to clarify with individuals, and to confirm their understanding of the requirements of their intervention, including their responsibilities and the likely consequences of any failure to comply16. methods of reviewing and evaluating the effectiveness of sentences17. methods of evaluating your competence when working with individuals, determining when further support and expertise are needed
