SFJFRSWF01 Prepare and plan for wildfire incidents



Overview

This standard is about preparing and planning for wildfire incidents. It covers your ability to identify and gather information and use it to contribute to national, regional or local strategies and operational plans for dealing with wildfire incidents. It includes assessing wildfire risk for your area of coverage, identifying resources and developing wildfire plans. As part of this standard you will be expected to work with other agencies and landowners.

This standard is recommended for wildfire specialists and those who have a strategic, tactical or operational role in dealing with wildfire incidents.

Performance criteria

You must be able to:

- P1 agree your role and responsibilities for wildfire response with relevant others in your organisation
- P2 identify and interpret sources of information about wildfire within your role in wildfire response
- P3 gather information that is up to date, relevant and meets your organisation's wildfire knowledge requirements
- P4 gather information about wildfire environments in your geographical area of responsibility
- P5 assess risks of wildfire to people, property and the environment in line with your organisation's risk assessment procedures
- P6 identify control measures to reduce risk to people, property and the environment in line with your organisation's risk assessment procedures
- P7 monitor information to identify triggers of increased risk of wildfire in line with your organisation's risk assessment procedures
- P8 contribute to risk management plans as required by your organisation
- P9 develop wildfire plans using information gathered in line with your organisation's requirements for operational readiness
- P10 review wildfire plans to respond to changing circumstances in line with your organisation's requirements
- P11 establish the range of resources available to respond to wildfire incidents in line with your organisation's resource procedures
- P12 allocate resources to wildfire plans to meet your organisation's requirements for wildfire response and wildfire response strategy
- P13 share information about wildfire plans with relevant others in line with your organisation's policies and procedures
