Manage political relationships and lobby for influence



#### **Overview**

This standard is about building and maintaining effective working relationships with local and/or central government, community and pressure groups towards developing their awareness and understanding positively regarding the issues of importance to you. It includes understanding their start point, developing messages and targeting those to be approached, and involvement in relevant decision-making processes through the lobbying of these groups or individuals.

#### Target group

This standard is aimed at workers whose role requires them to manage political relationships and to lobby for influence.

	6. identify activities and political communications methods designed to fulfil the agreed objectives and strategies
	7. engage in the direct or indirect lobbying of politicians and stakeholders
	towards achieving agreed objectives, using techniques that effectively present ideas and arguments

7. government procedures and protocols, the workings of government, and the lobbyist's role in exercising influence

8. the public policy and administration process

9. the mechanics of the legislative process, and associated procedures

10. public affairs techniques and how to use these towards influencing government and stakeholders

11. why it is important to show sensitivity to the needs and interests of others, and how to manage these effectively
