# SFJPDPS2.4.6 Identify external factors that may influence policy development



## **Overview**

Policy development may result from a reaction to current concerns or because of strategic planning and analysis. In either case, the policy will be developed in a long- term context and should take account of macro long-term trends in a number of areas. This unit is all about how policy development work should take account of those longer-term visions of the future.
