SFJPDPS2.7.4 Draw conclusions and make recommendations from policy evaluation



Overview

The move from a full evaluation and review to further policy development involves a crucial combination of sound analysis and creativity. It is vital that the conclusions drawn from the evaluation can be justified and that realistic and feasible ideas for development are generated. This unit is all about the process of formulating recommendations for policy change working from sound evidence.

Focusing on results

4. You focus attention on specific details that will influence the success of any actions that are recommended.

Acting ethically

5. You ensure that your recommendations for action comply with legislation, regulation, organisational policies and professional codes.

Acting strategically

6. You link the key features of any recommended actions with strategic objectives.
